AFFIDAVIT BY THE STUDENT

- 2) I have, in particular, perused clause 3 of the Regulations and am aware of what constitutes ragging.
- 3) I have also, in particular, perused clause 7 and clause 9.1 of the Regulation and am fully aware of the penal and administrative action that is liable to be taken against me in case I am found guilty of abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.
- 4) I hereby solemnly aver and undertake that.
 - (a) I will not indulge in any behaviour or act that may constitute ragging under clause 3 of the Regulations.
 - (b) I will not participate in, abet, or propagate through any act of commission or omission that may be considered ragging under clause 3 of the Regulations.
- 5) I hereby affirm that, if found guilty of ragging, I am liable for punishment according to clause 9.1 of the Regulations, without prejudice to any other criminal action that may be taken against me under any penal law or any law for the time being in force.
- 6) I hereby declare that I have not been expelled or debarred from admission in any institution on account of being found guilty of, abetting or being part of a conspiracy to promote, ragging; and further affirm that, in case the declaration is found to be untrue, I am aware that my admission is liable to be cancelled.
- 7) I am aware that if I involve in any violations/ repeated violations, I will lose privileges such as scholarship and placement services.
- 8) I hereby declare that during the study period, I will not involve in any type of misconduct of the following:
 - (a) Fighting/Slander/Quarrelling Resulting in Minor/Major Injury
 - (b) Smoking / E-smoking
 - (c) Coming in Drunken State / Inducing others to consume alcohol /Bringing Liquor / Possession of liquor /Drinking inside the Campus / Possession of even an empty liquor bottle
 - (d) Refusal or failure to wear uniforms/work dress/appropriate dressings within the Institute premises.
 - (e) Stealing/Theft
 - (f) Forgery/Multilevel Marketing / Gambling
 - (g) Drugs/Substance abuse
 - (h) Damaging the University's Property
 - (i) Any Cyber Crime / any other criminal activity / **Defaming VIT University's name in any Manner**
